Rules for the 4-H Parish Rabbit Show are contained as part of the 4-H Fall Fest rules. A copy is enclosed. Please read carefully.

All rabbits must be entered in advance. Parish show entry forms are enclosed. One form must be completed for each rabbit. If you need additional forms, make copies.

When completing the entry form, be as accurate as possible. Indicate the breed of rabbit in accordance with rule No. 6 on the enclosed 4-H Fall Fest rules.

All 4-H parish rabbit show entry forms are due in the 4-H office no later than **October 8**.

All rabbits entered in the show will be required to have an ear tattoo or ear mark in the left ear as a method of identification. An ear mark can be done with a marks-a-lot.

A clinic on selecting quality show rabbits and facility requirements for rabbits will be held on **Thursday, September 17th** at the 4-H Office from 5:30 – 6:30 p.m.

A tattoo and informational clinic on nutrition, health, show preparation will be held on **Thursday, October 8th** at the 4-H Office. The tattooing will be done underneath the building from 4:45 p.m. until 5:15 p.m. The informational clinic will be in the meeting room on the 3rd floor from 5:15 p.m. until 6:00 p.m. (*Tattooing will be done free of charge, but keep in mind that no rabbits will be allowed in the building for the informational clinic.*)
